KEY POINTS

- 1. Development of advanced nursing practice in Hong Kong is in alignment with the global trend to enhance effective and cost-effective care with quality.
- 2. Competencies for advanced nursing practice are explicitly defined by The Hong Kong Academy of Nursing & Midwifery (HKANM) and the affiliated Academy Colleges.
- 3. The HKANM has a well-developed mechanism to accredit Academy Colleges and certify advanced nursing practice.
- 4. Advanced nursing practice eventually needs to be regulated at the statutory level to protect the public and legitimize nursing practice at the advanced level.

BACKGROUND

The demand for health care is ever-increasing due to current demographic trend of longevity and advances in medical and nursing practices. With improved health literacy of the population, public expectations of better health care are rising. This provides an opportunity for nurses to expand and extend their current roles and perhaps create new ones. As nurses accumulate experience in their specialties and advance into higher education, they are keen to integrate theory into practice and build evidence to support their practice. This enables nurses in the modern era to contribute to the healthcare system in a more impactful way.

The scope of nursing is evolving over time, and the development of advanced nursing practice (ANP) is in alignment with the global trend. The qualification and competence for the initial entry to practise in nursing is not adequate to deal with contemporary health care demands. The contribution of nurses is not only in their sheer volume and numbers, but in their quality, in the sense that they provide expert care at an advanced level. The optimal use of nursing talent is for the benefit and well-being of the people they serve. Systematic reviews of nurses in ANP roles consistently show that their outcomes are equivalent to and sometimes exceed those of other members of the health care team, particularly in the aspects of health enhancement and chronic disease management. Patients consistently report high levels of satisfaction with the care provided by advanced practice nurses.

DEFINITION OF ADVANCED NURSING PRACTICE

Advanced practice nurse (APN) is an umbrella term to describe nurses practicing at an advanced level. Advanced nursing practice involves the emergence of new horizons of clinical nursing practice and expertise that go beyond basic nursing care and activities in meeting the health needs of individuals, families, groups and communities across the health wellness-illness continuum. APNs at a higher level of practice analyse and synthesize knowledge, master complex situations, interpret and apply evidence-based practice and research findings, and advance nursing standards and the profession as a whole. APNs assume collegial relationships in an interdisciplinary team and play a leading role in their area of expertise. These attributes are achieved at a higher educational level interacting with substantial years of nursing experience transiting from proficient to expert level.

Incorporating professional leadership, education and research through continued professional development, APNs demonstrate clinical reasoning, judgement, and skills at a higher-level capacity.

In Hong Kong, The Hong Kong Academy of Nursing & Midwifery (HKANM) was officially inaugurated in 2012. The mission of The HKANM is to advance nursing practice in Hong Kong to eventually reach statutory status in recognition of clinical specialists and leaders. It is supported by 14 Academy Colleges that represent all specialty areas of nursing practice in Hong Kong. The HKANM adopts the definition of the International Council of Nurses on advanced practice nurses, i.e. 'a registered nurse who has acquired the expert knowledge base, complex decision-making skills and clinical competencies for expanded practice, the characteristics of which are shaped by the context and/or country in which he or she is credentialed to practice. A master's degree is recommended for entry level. This requirement is in alignment with the global trend.

COMPETENCIES FOR ADVANCED PRACTICE NURSES

The HKAN has developed the Generic Competence Framework for Advanced Practice Nurses to guide the development of a specialty education program and specialist certification for its 14accredited Academy colleges. The colleges represent the full spectrum of specialty areas in which advanced practice nurses are engaged. The key domains of the competence framework include:

SPECIALTY CATEGORIZATION

Some of the Academy Colleges represent a single specialty and some have a broader base at the membership level and then build on to sub-specialties at the fellowship level. The six criteria of the Australia National Specialization Framework in establishing a recognized specialty are used as a reference. They are:

- i) The specialty has broad application in its geographic scope,
- ii) The specialty defines and subscribes to the overall purpose, functions and ethical standards of nursing and/or midwifery,
- iii) The specialty is a distinct and defined area of nursing and/or midwifery practice, which requires an application of specialty, focused knowledge and skill sets,
- iv) There is both a demand and a need for the specialty service from the community,
- v) The specialty service is based on a core body of nursing and/or midwifery knowledge, which is being continually expanded and refined with mechanisms exist for supporting, reviewing and disseminating research.
- vi) Specialty expertise is gained through various combinations of experience, formal and informal education programs, including but not limited to continuing education and professional development.

The 14 academy colleges address individual and population health needs across the lifespan from birth to death in a holistic manner. This covers in-patient, ambulatory and community care. The list of the 14 Academy Colleges is attached at appendix A.

POSITION ON EDUCATION, CREDENTIALING, PROFESSIONAL DEVELOPMENTAND STATUTORY GOVERNANCE OF ADVANCED NURSING PRACTICE

Education

Educational preparation for advanced nursing practice should be at master's level to support the competencies expected of nurses practicing at an advanced level. The HKANM stipulates that 500 hours each in both theory and practice need to be fulfilled before the nurse is eligible to undertake the college certification examination for membership in the associated specialty. At least one-third of the theory hours need to be fulfilled in generic, ANP-related and specialty-related respectively. Generic and ANP-related subjects include research, management, policy, advanced health assessment and pharmacology. The specialty-related core is specialty-specific, and includes advanced medical care, paediatric care and the like.

All theory and supervised practice at membership level has to be planned and completed according to the required competencies, which are to be recorded in the logbook provided by the specialty academy colleges within a minimum of 4 years of the accumulated 6 years of nursing experience. Experiential learning will continue for at least another 3 years before the mentee is eligible for the fellowship exit assessment.

Credentialing

To protect the public and the profession, the specialty education programs developed by academy colleges have to satisfy the assessment team of The HKANM Education Committee in their standards and mechanisms in certifying nurses practising at advanced level in the respective specialties. Certified Members, after fulfilling the clinical hours and competence standards and passing the written examination, will then be admitted as Members of the HKANM. Members will be admitted as Fellows after fulfilling the requirements stipulated by the academy College and passing a fellowship assessment conducted by the Academy College.

Professional Development

Nurses in different roles will have different development needs. Nurses need to review their current roles and identify areas in which they might benefit from further training, education and development, as a means of measuring progression and identifying ongoing learning needs. Advanced nursing practice encompasses advanced clinical practice, leadership, evidence-based and service improvement practice. Certified Members/Fellows are expected to complete the required continuous nursing education set by The HKANM.

Statutory Governance

The existence of a mechanism to certify advanced nursing practice in specific specialty areas is important in safe guarding standards of practice to protect the public. In the process of certification, there is a need for a well-defined, structured post-graduation curriculum, both in theory and practice. At present, in Hong Kong, there is only regulation for the entry level of the nursing profession at the registered and enrolled levels. All advanced practice nurses should have a valid certificate to practise at an advanced level in the related specialty, in addition to a general licensure to practise as a general Registered Nurse. The HKANM has a mission to set standards to ensure nurses practising at advanced level are fit to practise. Specialist practice in medicine in Hong Kong is regulated by the Hong Kong Academy of Medicine (HKAM), established under the Hong Kong Academy of Medicine Ordinance in 1992, and the specialist registry is managed by the Medical Council of Hong Kong. Advanced practice nurses in Hong Kong can model themselves after the HKAM, with the HKANM being the statutory body to accredit the academy colleges, certify APNs, and place the specialist registry in the Nursing Council of Hong Kong (NCHK). The mission of the HKANM is to establish a statutory credentialing system to protect the safety of the public and to legitimize the advanced nursing practice with structured education and standards.

SUMMARY

In Hong Kong, nursing is evolving, and nurses are extending and expanding their scope of practice beyond initial registration in different health care settings. There is evidence that advanced nursing practice contributes to better patient outcomes and fills the service gaps. Certification of advanced nursing practice in different specialty areas of practice is a mechanism to provide a clear direction for structured postgraduate curriculum design and

continuous training, in order to ensure that the best professional standards of care are provided to patients. A statutory governance framework should be established to ensure fitness for practice and consequent public protection. There is general agreement among the global community that nursing specialization is a trend in the attempt to meet the increasing health care demands. The NCHK, as a statutory body, only regulates the initial registration of nurses at present. However, the NCHK has decided in its scope of practice that professional nursing practice includes advanced and specialized practice in response to the changing health care environment. The HKANM has a system in place to accredit Academy Colleges and certify Members and Fellows who reach the stipulated advanced practice standards in related nursing specialties. On a par with international standards, the HKANM strives for statutory status to regulate professional practice and ultimately protect the public.
