#### **Minutes of Meeting**

#### Quorum

- 1. Ms. Gloria S.K. LUK, Hon Secretary, announced that due notice of meeting had been given to all members and confirmed that there was sufficient quorum.
- 2. Welcome to the guests and fellows to the AGM.
- 3. Welcome to Ms. Susanna W. Y. LEE, President of Hong Kong College of Paediatric Nursing, to join the council with effect from 9 August 2015 to replace Ms. Gloria S.K. LUK.

### Confirmation of minutes of last AGM

4. Dr. Susie S.S. LUM, the President, welcomed members to the 4th Annual General Meeting at 5:05 p.m. Dr. LUM advised that the Minutes of the 3<sup>rd</sup> AGM held on 20 September 2014 had been pre-circulated and the minutes were confirmed without amendment as proposed by Mr. TSANG W. W. - HKCON and seconded by Ms Helena Y.K. LI - HKCMN.

#### **President Report**

5. Dr. Susie S.S. LUM went on to give a detailed report of the work of the Academy in the past 12 months. The report included the achievements of the Council and its Committees. Reports on the Academy office, special projects, workshop and preparation for the legislation of The Hong Kong Academy of Nursing were also included. It was noted that the Academy had been involved in many local, national and international professional activities.

#### **Audited Financial Report**

- 6. Dr. Susie S.S. LUM called upon Dr. Esther E.H. WONG, the Honorary Treasurer, who advised that the audited financial report had been pre-circulated.
- 7. Dr. Esther E.H. WONG reported the financial position of the Academy for the year ended 31<sup>st</sup> December 2014. In the financial year 2014, a total of HK\$3,987,113 revenue recognized and HK\$3,248,000 operating expenses were incurred. The provision for Hong Kong profits tax of HK\$125,245 had been made on the estimated assessable profit for the year ended. After taxation, the surplus and total comprehensive income for the year 2014 was HK\$613,868. However, this financial year was ended with an accumulated fund of HK\$1,714,473 for the Academy and HK\$369,273 for the International Nurses Day Celebration Dinner.
- 8. Since there was no question raised, the audited financial statements and report of the auditors of the Academy for the period ended 31<sup>st</sup> December 2014 was confirmed as proposed by Mr. Frederick K. K. YEUNG HKCMHN and seconded by Ms. Helena Y.K. LI HKCMN.

#### **Appointment of Honorary Auditor**

 Dr. Susie S.S. LUM thanked Mr. CHAN Wai Hei William, the Honorary Auditor, for the genuine support to the Academy in the past year. Dr. Esther E.H. WONG proposed to re-appoint Mr. CHAN Wai Hei William to be the Honorary Auditor and seconded by Mr TSANG W. W. -HKCON.

#### **Election of the Council Member**

- 10. With the retirement of Ms. Civy S. K. LEUNG, there was one council seat to be filled at this AGM. Nomination was received from the Hong Kong College of Paediatric Nursing. Nomination was to nominate Ms. Civy S. K. LEUNG, Fellow of the Hong Kong College of Nursing and Health Care Management and the Hong Kong College of Surgical Nursing.
- 11. As there was only one nominated candidate, Mr. Lester HUANG announced Ms. Civy Leung has been elected by acclamation.
- 12. Vote of thanks was given to Mr. Lester HUANG for his genuine service to the Academy.
