Minutes of Meeting

Quorum

1. Dr. Susie S.S. LUM, President, announced that due notice of meeting had been given to all Members and confirmed that there was sufficient quorum.

Confirmation of minutes of last AGM

2. Dr. Susie S.S. LUM, President, welcomed Members to the 5th Annual General Meeting at 2:40 pm. Dr. LUM advised that the Minutes of the 4th AGM held on 8 August 2015 had been pre-circulated and the Minutes were confirmed without amendment as proposed by Dr. Esther Y.H. WONG and seconded by Ms. Helena Y.K. LI.

President Report

- 3. Dr. Susie S.S. LUM thanked the Patron, Honorary Advisors, Honorary Auditor, Honorary Legal Advisor, Honorary Consultant, Honorary Executive Consultant, the Office staff for their support to the Academy.
- 4. Dr. Susie S.S. LUM went on to give a detailed report of the work of the Academy in the past 12 months. The report included the achievements of the Council and its Committees. Reports on the Academy Office, special projects, workshops and preparation for the legislation of The Hong Kong Academy of Nursing were also included. It was noted that the Academy had been involved in many local, national and international professional activities.
- 5. Ms. Alice S.Y. SHAM proposed and Ms. Civy S.K. LEUNG seconded to receive the President Report.

Audited Financial Report

6. Dr. Susie S.S. LUM called upon Dr. Esther Y.H. WONG, the Honorary Treasurer to report. Dr. Esther Y.H. WONG reported that the reports had been pre-circulated to Members.

- 7. Dr. Esther Y.H. WONG reported on the financial position of the Academy for the year ended 31st December 2015. The Academy ended the year with an accumulated fund of HK\$2,333,596. In the financial year 2015, total of HK\$3,068,210 revenue recognized and HK\$2,818,360 operating expenses were incurred. No provision for Hong Kong profits tax has been made as the Academy is exempted from all taxes pursuant to Section 88 of the Inland Revenue Ordinance with effect from 8 January 2015. The tax recoverable was HK\$35,034. The net surplus for the year 2015 was HK\$248,850.
- 8. Since there was no question raised, Ms. Helena Y.L. LI proposed and Ms. Y.M. LAM seconded to receive the audited Financial Statements and Report of the Auditor for the period ended 31st December 2015.

Appointment of Honorary Auditor

 Dr. Susie S.S. LUM thanked Mr. CHAN Wai Hei William, the Honorary Auditor, for the genuine support to the Academy in the past year. Prof. Frances K.Y. WONG proposed and Dr. Esther Y.H. WONG seconded to re-appoint Mr. CHAN Wai Hei William to be the Honorary Auditor.

Election of the Council Member

10. With the retirement of Dr. Susie S.S. LUM, there was one council seat to be filled at this AGM. Three nominations were received. The nominees were:

- 14. The Voting Form was distributed to the representatives of the Institutional Members and being collected afterwards. Mr. Lester HUANG and Mr. William CHAN examined that all the 12 returned Voting Forms were valid and counted the votes.
- 15. Mr. Lester HUANG announced that Ms. CHONG Yuen Chun Samantha got the majority of votes and was elected the Council Member.
- 16. Vote of thanks was proposed to Dr. Susie S.S. LUM, President 2011 2016, for her dedication and support to the establishment and development of the Academy since 2002. Dr. Susie S.S. LUM would join the Academy Council in the capacity of Immediate Past President.
