### **Explanatory Notes**

- (a) Each Member is entitled to appoint another person as a proxy to attend the Annual General Meeting.
- (b) Any Member entitled to attend and any Institutional Member entitled to vote at this meeting is entitled to appoint a proxy to attend in his stead. In accordance with the Articles of Association of the Academy, only a proxy of an Institutional Member is entitled to vote in the Annual General Meeting and to nominate a candidate to stand for election to the Council. The proxy must be a Member of the Academy. The instrument appointing a proxy shall be in writing under the hand of the appointor and shall be deposited at the registered office of the Academy at LG1, School of Nursing, Princess Margaret Hospital, 232 Lai King Hill Road, Kowloon, Hong Kong not less than 48 hours before the time for holding the meeting

- \* *Ms. CHONG Yuen Chun Samantha has* submitted a notice on 29<sup>th</sup> May 2017 that she will be resigning as the elected Council Member with effect from 16<sup>th</sup> June 2017, thereby, another Council seat is open to fill at the Annual General Meeting.
