#### **Explanatory Notes**

- (a) Each Member is entitled to appoint another person as a proxy to attend the Annual General Meeting.
- (b) Any Member entitled to attend and any Institutional Member entitled to vote at this meeting is entitled to appoint a proxy to attend in his stead. In accordance with the Articles of Association of the Academy, only a proxy of an Institutional Member is entitled to vote in the Annual General Meeting and to nominate a candidate to stand for election to the Council. The proxy must be a Member of the Academy. The instrument appointing a proxy shall be in writing under the hand of the appointor and shall be deposited at the registered office of the Academy at LG1, School of Nursing, Princess Margaret Hospital, 232 Lai King Hill Road, Kowloon, Hong Kong not less than 48 hours before the time for holding the meeting

- \* In accordance with Article 49 of the Articles of Association of "Academy", *Ms. LEUNG Sui Kei Civy*, shall retire by rotation, and, a Council seat is open to fill at the Annual General Meeting.
- \* In accordance with Article 49 of the Articles of Association of "Academy" endorsed in EGM on 3<sup>rd</sup> March 2018 for the creation of two council seats and it is agreed that one council seat is open to fill at the Annual General Meeting.

For nomination of candidate(s) to stand for the election, that is, two seats, the enclosed nomination form must be properly completed and returned at or before 9:30 a.m. of 15<sup>th</sup> June 2018.
